The produced workbook is an annual labor-distribution list, not a shift roster. It identifies Misty Jones, Jeremy Jones, Mason Wilborn, Josh Swindle, Joseph Martin, and Matthew White. John Long does not appear, and the list does not establish which Jones employee is the CO Jones described by Plaintiff.

Source pages included

Record limitation

MAR and status entries show the system user and recorded outcome, not how the medication was physically administered. Katlyn Ladd appears in staffing and dissolve-task records, but the produced Biktarvy MAR/history does not show a Biktarvy pass by Ladd. The source records spell Ashley Watt singular (pleaded/docketed as Ashley Watts).

I, Jason Matthew Lynch, declare as follows:

1. I am the Plaintiff in this action. I make this declaration from personal knowledge and could testify competently to the matters stated below.
2. I was incarcerated at the White County Detention Center in White County, Arkansas, from approximately June 9, 2024, through September 9, 2024.
3. While incarcerated, I arranged for a person outside the detention center to obtain official federal prisoner civil-rights complaint forms, filing instructions, and in forma pauperis forms and mail those materials to me at the detention center.
4. The materials were sent in a United States Postal Service Priority Mail package addressed to me and marked 'LEGAL MAIL.'
5. I was not called to receive or open that package, and the package and contents were not delivered to me during my confinement. I did not authorize anyone to open the package outside my presence, withhold it from me, or place it into stored property without giving me access to its contents.
6. When the package was recovered from my stored personal property, it had already been opened. It contained the federal court materials described above, and the package or associated materials displayed the words 'DO NOT GIVE TO INMATE.'

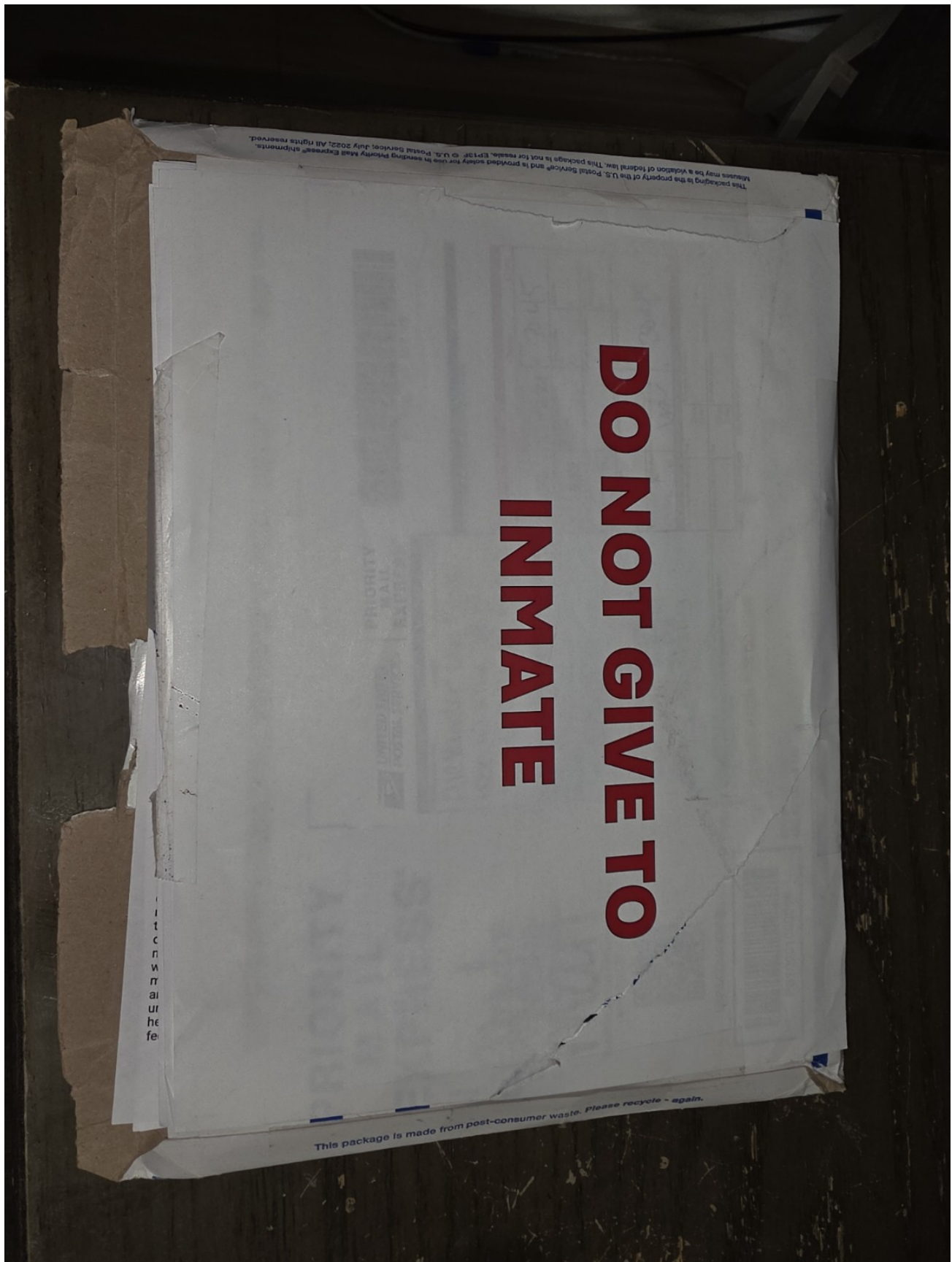

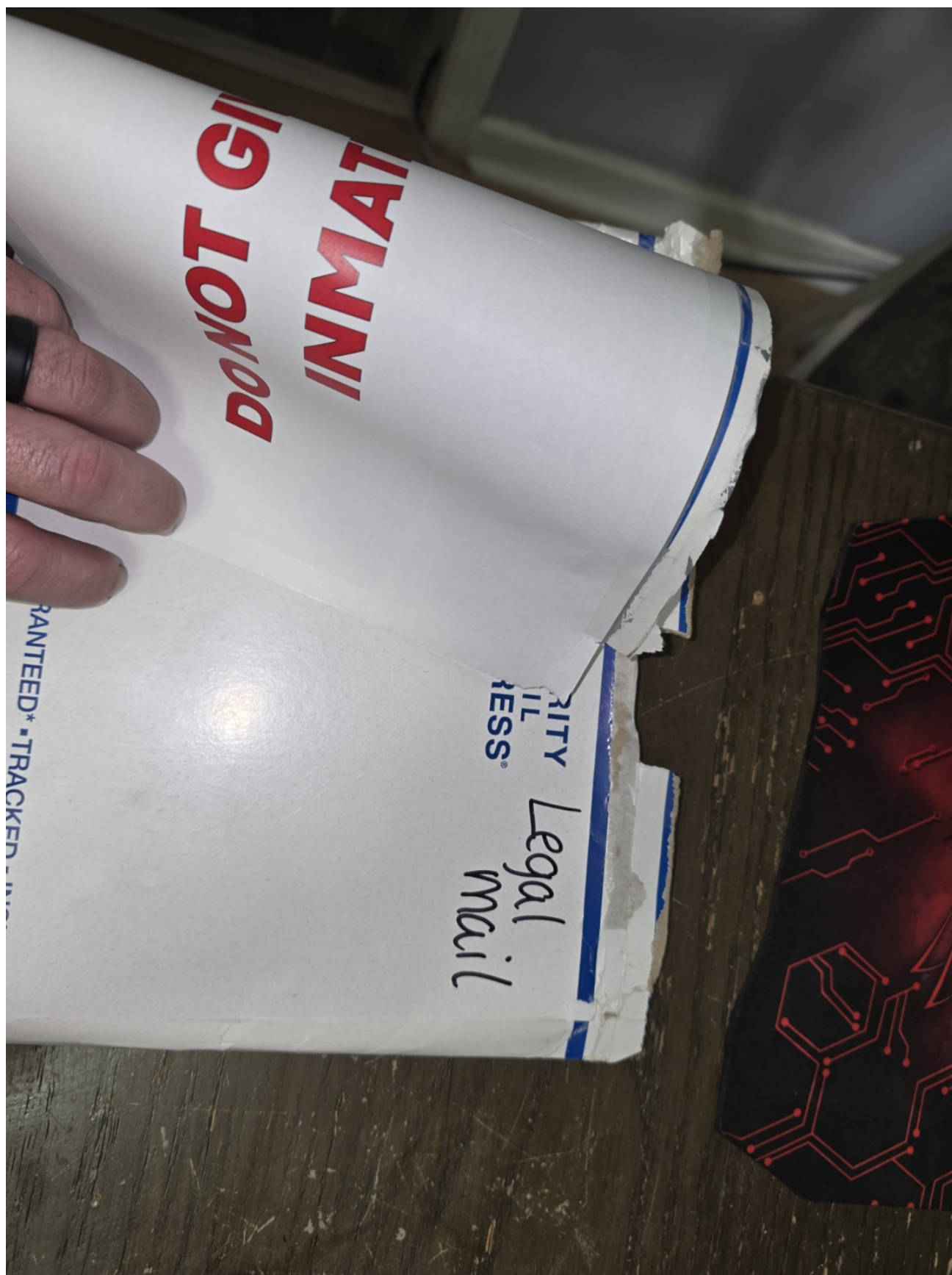

Photograph 1: Package and contents marked "DO NOT GIVE TO INMATE."



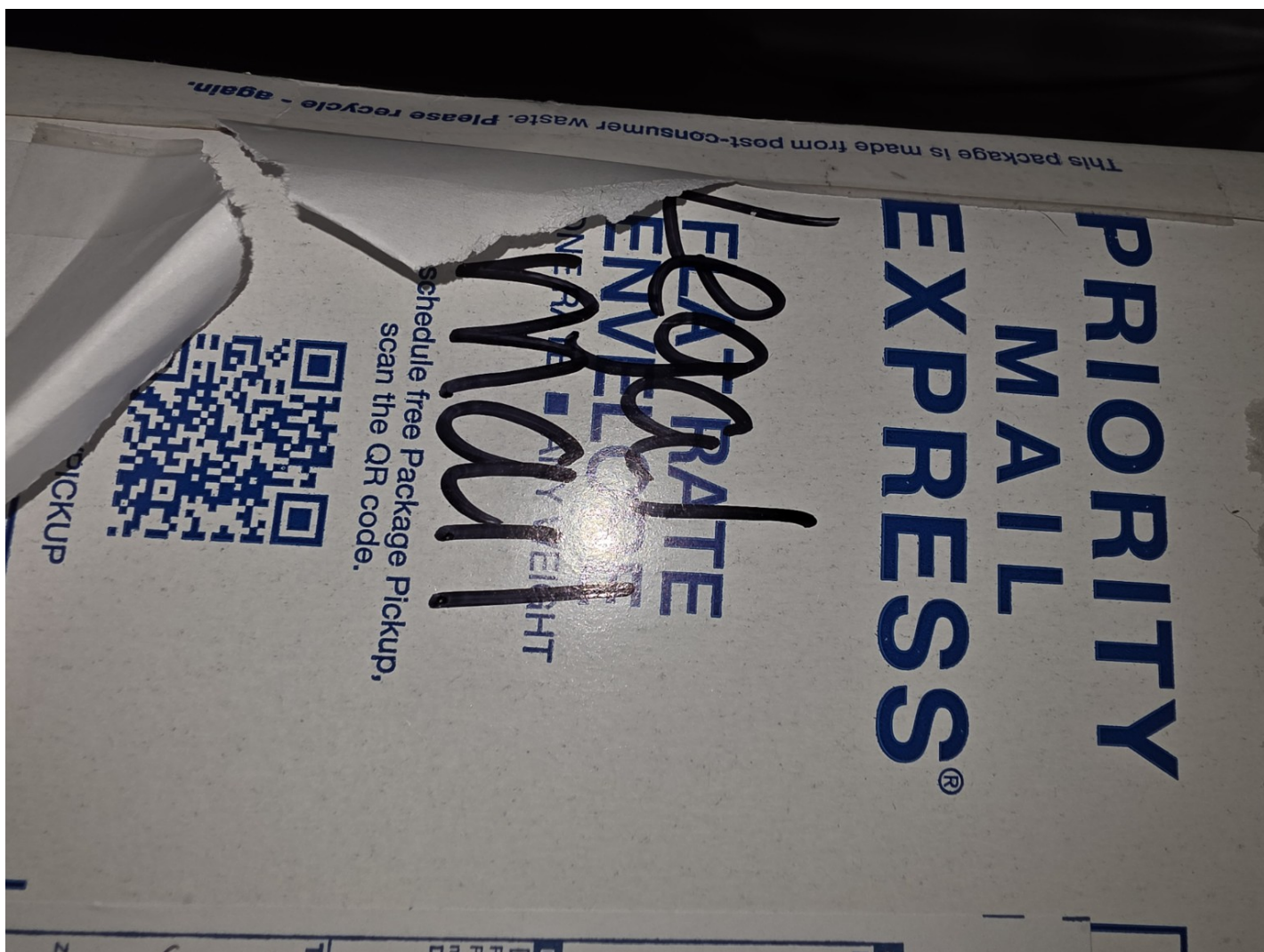
Photograph 2: Opened package with handwritten "Legal Mail" notation.

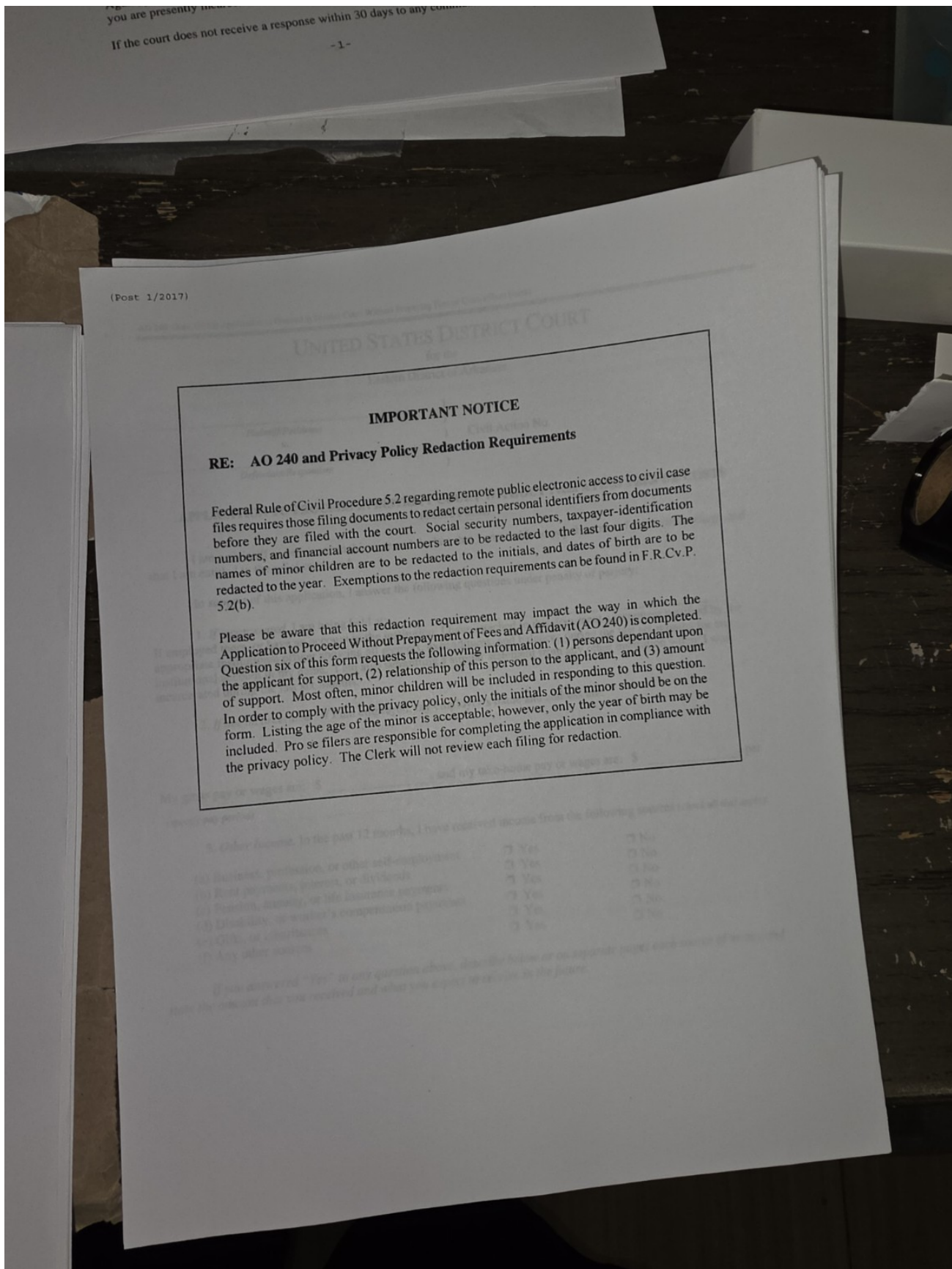

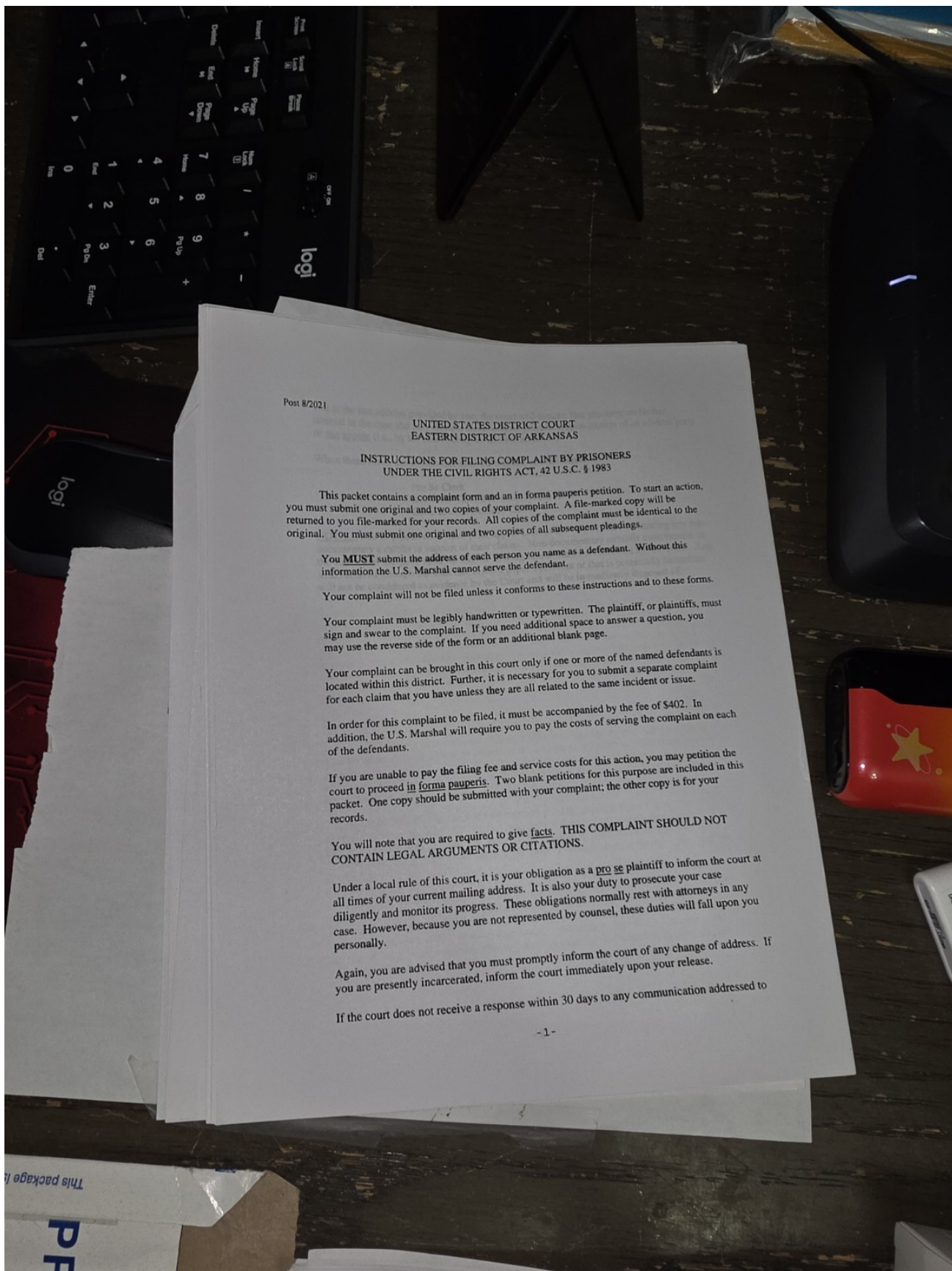

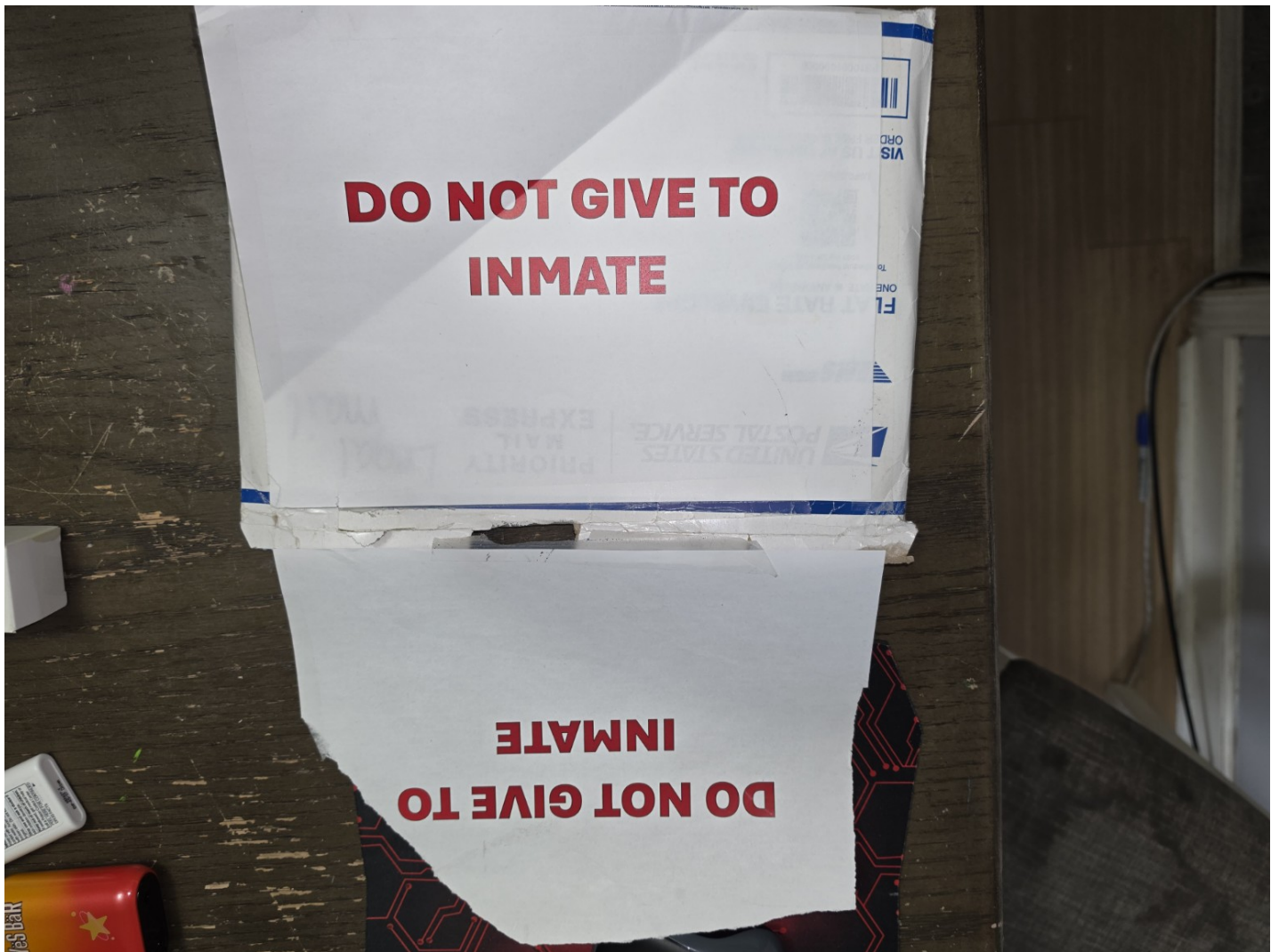
Photograph 6: Federal court privacy/redaction notice contained in package.

The material is offered to preserve the discrepancy for authentication, discovery, and trial.

segregation, which included the suspension of mail, telephone, visitation and commissary privileges).

Lynch was transferred from WCDC on September 7, 2024. (Doc. 45 at 6). Thus, his time in medical lockdown lasted no more than 15 days. This temporary detention, standing alone, does not constitute an “atypical and significant hardship... in relation to the ordinary incidents of prison life.” *Sandin*, 515 U.S. at 484. Although Lynch alleges that the cell and shower in medical lockdown had “human waste, blood, [and] black mold everywhere,” (Doc. 45 at 44, 63), and he was not provided cleaning supplies, he alleges similar conditions existed in F Pod, *id.* at 62–63. Thus, the conditions in lockdown were not “atypical” enough to implicate a liberty interest for Lynch. Accordingly, Lynch fails to state a due process claim based on his transfer to medical lockdown.

9. Equal Protection

Lynch vaguely alleges that he was discriminated against as a “class of one” without rational basis, and Defendants denied him “equal protection of laws and equal privileges.” (Doc. 45 at 23, 78). Because Lynch does not allege that he was treated differently from similarly situated inmates based on a suspect classification or a fundamental right, to state an equal protection claim, he must show that Defendants systematically and “intentionally treated [him] differently from others similarly situated and that there is no rational basis for the difference in treatment.” *Nolan v. Thompson*, 521 F.3d 983, 989–90 (8th Cir. 2008); *see Patel v. U.S. Bureau of Prisons*, 515 F.3d 807, 815–16 (8th Cir. 2008).

Lynch does not specify which actions allegedly violated his equal protection rights but, upon review of the Third Amended Complaint, the only action that appears to fit this
