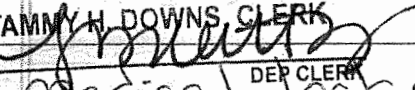

This took place in medical @ Tue 9-3-24 I think. But the words of the medical nurse & Co and the actions just further prove that this is nothing but reprisal for contacting DOJ OIG - for being a "Whistle Blower" on his sick actions... How can he run a jail with his personal feelings involved...

9-5? I don't know the time it's after lunch, I've offered to give up, a cellphone, lighter, & tattoo needed with ink and smoke but caption will not take my ~~offer~~ offer for these to be moved back to pop. Further proving this is reprisal or pay back for filing 1983 and blowing the whistle to the DOJ OIG... The pill nurse told me last night again "Smith" this was by order of the caption, but that it was stupid of them to do this. Sgt Siler body cam was on

 I'm still locked down in m2 I've only  
 see a Co 2 today and was dumping chew  
 to drop off a tray. I've hit the button  
 at least 20 times in past 5 hours and  
 never got any response. I'm clearly not  
 in medical so medical can "watch me  
 like the Caption said..

1-S 24 @ 7:30 21,091,464 I informed the  
 sheriff of my complaint to the DOJ  
 OIG and 1983 - I asked how can  
 he allow the captain to retaliate  
 against me like so. I informed the  
 sheriff that medical said this was  
 stupid. I even asked if I'm a whistle  
 Blower should I not be protected from  
 the person I'm Blowing the whistle on  
 or that the person in my 1983 or  
 complaint should be the person I'm  
 protected from. I offered a lighter,  
 weed, tattoo needles, ink, cell phone, and  
 how it's hid, and how it get in. But  
 the Caption & Sheriff had no interest in  
 that. They only want as much harm  
 to me done as they can. 3 full days  
 locked down, I'm not ok, I'm not  
 doing well. I don't do good like the

I guess its around 5pm. I'm in medical lock down per captain edwards for medical reasons but when I press the button I'm ignored, no answer, and no one has checked on me in over 5 hours... Clearly not locked down for medical reasons but ~~came~~ at the order of the Capt. for reprisal...

30 min later I pressed the button again and still no answer what so ever cam footage from m2 will show this as well

The cell is nasty and they will not give me anything to clean it, even after I ask

hour later I pressed the button again and still no answer at all... This proves I'm not here for any medical reason at all

Even when I knock on the door cause I can hear the nurse I'm simply ignored. Once again proving this lock down is reprisal

Co Chisim well Sgt chisim let me out to make phone calls and place commissary order. She said you have all treated me with respect so I will do the same with you... While I was out the pill nurse crushed & flouted my pill just like she said would have in the POD. The Dr orders still in room with m 11

9-5  
 Open I was given rotten food for dinner and told to eat around it. I asked to call the federal inmate hot line to the DOJ OIG and was told no, that I'm crazy not ~~that~~ hot line exist. I told them is all over the ~~base~~ walls at the ~~federal~~ federal court house and again I was told I don't know what I'm talking about. All Hell broke loose in Medical, they tested & massed a mentally ill woman more than once. she has been screaming help for the past hour and staff laughs at her.

9-9-5 I've put in 3 request, 2 grievances and sent out 2 hand written letters saying I don't need medical treatment, I did not ask for medical ~~trac~~ treatment, nor am I sick. I again offered up real security concerns, like a light, rolling papers, weed cell phone, tatoos and hair. But they have all been blown off. All Guards, tell me it only the caption can save me, that it's his orders that I be placed in lockdown

Sgt Hughes, Sgt Siler, Sgt workmen and medical nurse Smith all told me the Captain ordered me to be locked down in medical. Further proof of reprisal at the hands of by order of the captain for filing 1983 and contacting DOJ OIG

4-5 Still in medical I have pressed the button over and over and I'm slowly ignored.. I'm clearly not here ~~for~~ for medical to watch my health

1-6 Inmate Ricky Brown 858146 last toe 3pm medical called 911 and sent him to the ER less shaken, fluid on heart and heart failure. Pro med picked him up.. He returned Friday at 4pm. was given no mat and has been laying on floor of medical asking for help. 830 pm he still has seen medical, still has not been given a mat. Blanket or anything. at shift change they asked him ~~what~~ why he was in here. But still no basic care has been given, he legs are bigger than his head, ~~he~~ he is in pain shaking. he has asked for a mat 10 times in the past few hours. There is no care - no life at all...

9-7 or 9-8 at shift change cleaning of medical shows mis handling of mental inmate again - last time she was tazed & maced this happened Sunday approx 6pm in medical co wilburn, co snipes, co hardgrove and 3 medical cars

while in medical no table to write letters on or ~~eat~~ no table to eat on footage from cam cell m-2 will show we had to use bunk or floor to eat on and write letters on

even after being moved to medical so my pill could be disclosed, its still been crushed floored then disclosed, still leaving abt 20% of pill in bag..
