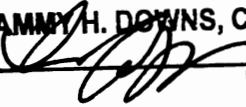

 Please be advised that staff will not complete my in forma pauperis papers. They stated they have already done so twice. This is true they have put the packet never seems to make it back to the court house. This is my 3<sup>rd</sup> complete packet sent. I've learned to send my legal mail out at night, that seems to circumvent the Caption from intercepting my out going legal mail. This action is also one of my claims.

LT Ross sent an email to all guards and staff not to sign anything at my request, even my in forma pauperis papers were refused... (also one of my complaints)

Since my legal legal mail and documents were gone through by staff and Guards (also one of my claims) every 2 days on night shift I mailed my log and other plaintiff statements, were mailed to Alexander low from in Jacksonville FL his cell is 545291071 office 9069820529. I am "Pro Se" I mailed to him for safe keeping as I have known him over half my life..

I am asking him and Luke Rowen to help me pro bond but that has not happened yet.

The log I mailed to Alexander law firm is in far greater detail than my brief facts listed in this packet.

I have over 20 inmates a witness and 7 different Guards willing to appear on my/our behalf.
