OMNIBUS MOTION TO RE-SEND FILINGS,
NOTICE OF CHANGE OF ADDRESS, AND REQUEST
FOR ADDITIONAL COURTESY NOTICE

COMES NOW Plaintiff, Jason M. Lynch, pro se, and respectfully states:

1. Mr. Lynch respectfully informs this Honorable Court that he is in the process of being released from federal custody and transitioned from a Federal Bureau of Prisons facility to a Residential Reentry Center ("RRC") and ultimately to home confinement.
2. Mr. Lynch has been advised that this transition process may take several weeks to complete. Mr. Lynch must first report to the RRC, complete intake and orientation procedures, and then await placement onto home confinement status.
3. At this time, Mr. Lynch does not know the precise timeline for completion of this transition, nor does he know how quickly the RRC will complete processing and placement procedures.
4. Due to this transition, Mr. Lynch has substantial concern that mail sent to him after May 15, 2026, may not arrive at the federal institution in time to be delivered before his transfer and release.
5. Mr. Lynch therefore respectfully moves this Court for an Order directing that any filings, notices, correspondence, orders, or other documents mailed to Mr. Lynch on or after May 15, 2026, be re-sent to his updated mailing address listed below.
6. Mr. Lynch respectfully submits this filing as both:
 - (a) a formal Notice of Change of Address; and
 - (b) a Motion requesting re-mailing of any filings or notices sent after May 15, 2026, that may not have been received.
7. Mr. Lynch will diligently monitor Arkansas CourtConnect and any other available docketing systems to the best of his ability during this transition period in an effort to remain informed of all activity in this matter.
8. However, because Mr. Lynch is in transit between federal custody, the RRC, and eventual home confinement, there exists a significant risk that filings mailed during this period may not reach him in time or at all.

9. Mr. Lynch respectfully requests that the Court and Clerk continue working with him during this transition period so that no deadlines, rights, filings, or notices are unintentionally missed due solely to mail complications associated with federal release procedures.

10. Mr. Lynch further respectfully states that his respect for this Honorable Court, its Clerk's Office, and all court staff is great and deeply profound, and he sincerely appreciates the Court's patience and consideration during this unusual transitional period.

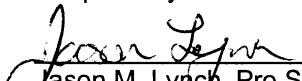

- D. Grant all other relief deemed just and proper.

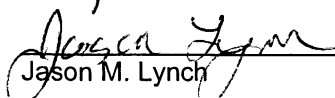

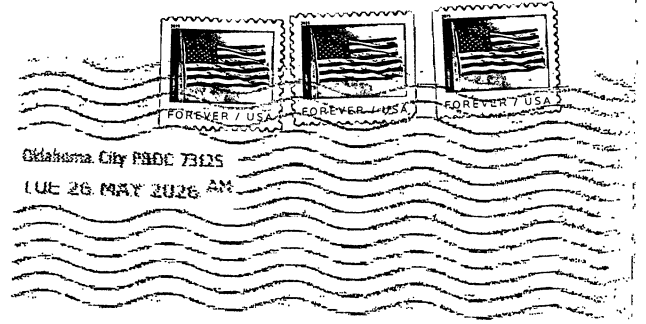
